Cheating case: SC interim bail to Vikram Bhatt wife

New Delhi, February 13

THE SUPREME Court on Friday granted interim bail to film director Vikram Bhatt’s wife, Shwetambari V Bhatt, who was arrested along with him in a cheating case.

A bench of CJI Surya Kant and Justice Joymalya Bagchi directed that Shwetambari, who is lodged at Udaipur Cen-

tral Jail, be released forthwith on interim bail upon furnishing bail bonds to the satisfaction of the Chief Judicial Magistrate Court, Udaipur.

Senior Advocate Mukul Rohatgi, who appeared for Shwetambari, told the Bench that “police came to our house in Mumbai and picked us up only because some movies were a flop”. A counsel, appearing for the Rajasthan-based doctor, Ajay

Murdia, who had filed the complaint, said, “It’s not that simple,” adding that it involved about Rs 44 crore. Justice Bagchi asked him, “So this criminal case will be used to recover your dues?” “Unfortunately, they have not sought quashing of this complaint,” the CJI added.

Rohatgi said, “He wanted movies on himself. Two movies were made, but they flopped. It’s not my fault.”

Restore expunged portions of my speech: Kharge to Chairman

RAJYA SABHA Leader of the Opposition Mallikarjun Kharge on Friday said that a large portion of the speech on February 4 during the Motion of Thanks on the President’s Address including comments criticising certain policies of the PM were “either expunged or removed” without proper justification.

Kharge said that this was against freedom of expression guaranteed to MPs under Article 105(1) of the Constitution, and urged Chairman C P Radhakrishnan to consider restoring the expunged portions. He underlined he had not made any unparliamentary remarks that merited expunction.

A perusal of the verbatim transcript available in public of Kharge’s February 4 speech showed that at several places, parts of the speech have been marked as “not recorded”. From the treasury benches, Union Finance Minister Nirmala Sitharaman objected to Kharge’s charge as “disrespect” to the Chairman and “not appropriate.”

If he did not receive justice in

this matter, Kharge said, he would be compelled to share the version “not recorded” with the public. Radhakrishnan said he will look into the issue but added that whatever has been expunged from records cannot be released outside. The Chairman said, “... How can you say that? Whatever has been expunged, you cannot say that.”

Rajya Sabha proceedings were adjourned on Friday until March 9. The Upper House met for Zero Hour at 11 am and was adjourned at 1 pm after the scheduled Question Hour.

Raising the issue just before the Question Hour was to

begin, Kharge said, “... Upon reviewing the verbatim transcript of the speech uploaded on the Rajya Sabha website, I found a large portion of my speech has been either expunged or removed without any proper justification or rationale.”

“I found that the unrecorded portions of my speech are those in which I made comments, supported by facts, on the functioning of Parliament during the current government’s tenure and criticised certain policies of the PM (Narendra Modi) — which is also my duty as the LoP, because I believe those policies are having an adverse impact on the Indian public,” he said.

Responding to Kharge, Finance Minister Nirmala Sitharaman quoted Rule 261 on proceedings of the Council, and said that the Chairman had discretion to expunge remarks, and the Leader of the Opposition was “disrespecting” the Chairman.

She said what the LoP was trying to suggest was based on his own judgment. “To suggest it is to protect the PM is not appropriate for the position of the LoP,” she said.

Class 12 student rams car into pedestrians, kills 6-year-old in UP

A CLASS 12 student driving back from his school farewell party allegedly ploughed into several pedestrians, killing a six-year-old boy and injuring four others, including two women, in Lucknow’s Banthara area on Thursday evening, said police. According to police, it appears the driver allegedly lost control of the Swift Dzire, first crashing into an autorickshaw and then ploughing into pedestrians walking along the road.

Police said the accused fled the spot in the car before abandoning it. They later tracked him down and detained him on Friday. They have also seized the car, which belonged to his friend.

Police said a case has been registered at the Banthara police station under various sections, including rash and negligent driving, among other charges. “The driver claimed

the accident occurred after one of the car’s tyres burst. The vehicle belongs to his friend,” said ACP, Lucknow, Rajnish Verma.

The victim, Dikshant Patel, was walking by the roadside with his mother and grandmother when the car ploughed into them near the Hanuman temple. He suffered a severe head injury and later succumbed during treatment.

The four injured have been identified as Dikshant’s mother, Sadhna (35), and grandmother, Meena Devi (60), Arman (12) and Awadh Bihari (42).

UNSC panel takes note of Jaish role in Red Fort attack

A REPORT by the UN Security Council sanctions monitoring team has noted that Pakistan-based terror group Jaish-e-Mohammed was reported to be linked to a terror attack on the Red Fort in New Delhi last November that killed 15 people.

“One Member State noted that Jaish-i-Mohammed had claimed responsibility for a series of attacks. It was also reported to be linked to an attack on the Red Fort in New Delhi on November 9 that killed 15 people,” the 37th report of the

Analytical Support and Sanctions Monitoring Team submitted to the Security Council 1267 Sanctions Committee concerning ISIL and Al-Qaida said.

The report, issued here, added that on October 8, JeM leader Mohammed Masood Azhar Alvi “formally announced the establishment of a women-only wing, Jamaat ul-Muminat, which was aimed at supporting terrorist attacks.” Even as another member state reported that Jaish-e-Mohammed was defunct, the report added that “separately, it was reported that

on July 28, three individuals allegedly involved in the attack perpetrated in Pahalgam, in Jammu and Kashmir, were killed.”

At his weekly briefing in New Delhi on Thursday, Ministry of External Affairs (MEA) spokesperson Randhir Jaiswal was asked for a comment on the UNSC report.

“This particular report that you refer to, it is available in public domain. It is online. This was the 37th Report of the Analytical Support and Sanctions Monitoring Team. This was published on February 4, 2026,” he said.

Days after cop’s death, ride section cordoned off, but show goes on

DAYS AFTER a “Tsunami Swing” collapsed and claimed a policeman’s life at the Surajkund International Crafts Mela, the section of the fair housing the amusement rides remains cordoned off with yellow tapes put around it. At least five special police officers are always stationed at the spot since Monday, with the number rising to even seven in the evening when the footfall increases.

“Of course it hurts,” Special Police Officer Phool Singh, deployed at the rides section, said on Thursday, referring to the death of Inspector Jagdish Prasad (59) last Saturday. Singh and others are on eight-hour shifts in the section.

“No one has ventured into the area today (Thursday) apart from the mela staff,” Singh said.

Food stalls set up near the swing before it collapsed have also been moved.

“The incident affected businesses. We are barely managing costs. If this goes on, half of the food will remain unsold,” said Vijay Kumar (37). The *choley bhature* stall he works at was located near the swing, and its proprietor-worker Balbir Singh was among those injured, as he volunteered to rescue people after the swing collapsed.

Balbir, who is recuperating at his Sultanpuri residence in Delhi, said: “There are three fractures in my right hand. I cannot work for three months. I have two young children to take care of. What happened to the policeman is tragic... we used to have tea and snacks together after his shift ended.”

A little away, the owner of a hoopla ring game stall, Ballu (35) shouted — “12 shoes for Rs

100” — to attract customers, but in vain. “It is becoming very difficult. For a couple of days after the incident, we had to shut our stalls. But the crowd is thinner even now, after days.”

A panipuri seller, wishing not to be named, concurred. Even as stall owners claimed to incur losses, though wary, many visitors turned up at the mela.

Deepak Kumar (26), who was accompanied by his wife, said on Thursday: “These (melas) happen once a year. We cannot miss it because of one mishap.”

Sudhir Gupta (34), a small businessman from Bihar who resides in Gurgaon, visited the mela with his wife and child. He said he was unaware about the last week’s incident. “But it was

an accident. Should we stop coming to melas because of that?”

People seemed to agree with Sudhir and Deepak as they started thronging the stalls to buy handicrafts and pose with African performers at selfie points. Teens were spotted making reels for social media, standing not very far from the rides section.

A Faridabad Police spokesperson said that currently three of those who sustained injuries in the swing collapse are at admitted to Supreme Hospital. “While two are recovering, one is in the ICU,” the spokesperson said. The others who sustained injuries have been discharged on Monday.

Special officer Singh’s colleague and former Armyman

SPO Rakesh Kumar (52), felt pain in the chest while he was on way to Jhanjhar on Monday evening. “I got a check-up done at a private hospital. Following scans, I was told one of the ribs is severely damaged. So, I got admitted...”

“People are attending the fair. Well, who can stop them? But we lost a very dear one,” he said, remembering Prasad.

According to officials, between Monday and Thursday, over 2.7 lakh people have visited the mela — which will go on till February 15. On Sunday alone, a day after the incident, 2.2 lakh visited the fair, Haryana Heritage and Tourism Minister Dr Arvind Sharma had said. The mela has seen a footfall of over 10 lakh so far, officials added.
