Apollo survey: Less than 3% of vaccinated health staff infected

SUKRITA BARUAH

NEW DELHI, MAY 19

AS CONCERN rises over reports of Covid-19 infection even in fully vaccinated people, a survey among healthcare workers at one of Delhi's biggest hospitals has shown that among those who had received both doses of the vaccine, fewer than three out of every 100 individuals were in-

No Covid-related deaths were reported in the fully vaccinated group at the hospital, the survey found.

The Indian Medical Association (IMA), the country's largest voluntary association of doctors with over 3 lakh members, said on Tuesday that as many as 269 of its members had died of Covid in the ongoing second wave of the epidemic.

"This (deaths) is indeed very sad and while I mourn the loss I would like to share important data - Out of 3.600 doctors. nurses, and healthcare workers vaccinated with two doses at Apollo Hospitals Delhi, only 2.6 per cent got infected with mild Covid-19 and no death," Dr Sangita Reddy, joint managing director of the Apollo Hospitals

Group, said in a social media

The observational study was conducted Delhi's at Indraprastha Apollo Hospital during the first 100 days of the vaccination drive, during which Serum Institute of India's (SII's) Covishield vaccine was administered to healthcare workers at the hospital.

The study covered 3,235 healthcare workers, of whom 85 were infected during the study period. Of those infected, 65 had been fully vaccinated, and 20 were partially vaccinated.

Meanwhile, the Delhi Medical Association (DMA) is working to find out the vaccination status of each of the doctors who succumbed to the virus in Delhi in this wave.

DMA president Dr G S Grewal said, "We are conducting a survey to find out the vaccination status of each doctor. We are asking how many got the first dose and how many days after did they get Covid and die.

"Similarly, we are also finding about the second dose of the vaccine and when they got Covid and died. This should take around five days.

According to the IMA, the largest number of deaths of doctors had occurred in Bihar (78), followed by Uttar Pradesh (37), and Delhi (28). A DMA official said it was

likely the number of deaths of doctors in Delhi was higher because not all doctors were members of IMA or DMA.

"We have got more names (of doctors who have died) over the past few days and are finding out how many died in this wave. We have been alerted that the number in Delhi might be higher, and will check details and come out with a final number soon," another DMA official said.

Telangana floats global tender Tihar inmate beaten to death with cricket bat, 4 held HYDERABAD, MAY 19

FOUR DAYS after a 33-year-old inmate was allegedly beaten to death inside Tihar Jail by four other inmates, an investigation by Delhi Police revealed that a cricket bat was used in the assault. The four men have been arrested and police are seeking production warrants to question them.

DCP(West)Urvija Goel said the deceased, Srikant alias Appu, was a resident of Ashok Viĥar. "We have registered an FIR and our initial investigation has revealed that the brawl started between Srikant and other inmates over bullying. Further investigations are on." The complainant Lalit, who is a warden in Central jail 2, told police he and his colleague, Praveen, saw the four accused use a cricket bat to thrash the deceased, "Lalit told police that at around 6 am, they opened all the barracks and were sitting in the guard room. Around 7 am, they heard some noise coming from barrack 4, and they immediately rushed. They found that four inmates of barrack 6 – Kishan Shresth, Kunal Akash and Arun were beating Srikant inside barrack 4 with a cricket bat. They were threatening to kill him and blood was oozing out from Arun's head. They took Arun to the jail dis-

pensary and also tried to take Srikant, but he refused to come after saying he would take rest in his room. A senior officer was informed at around 9 am. Srikant then informed he was in pain. He was referred to Safdarjung Hospital, where he was declared brought dead," a police officer said. Police found that Srikant hit Arun with a sharp-edged weapon and the other accused hit him with a cricket bat.

The goods to be supplied must be as per the guidelines issued by ICMR, Telangana State Medical Services and Infrastructure Development Corporation said in the tender document issued on Tuesday.

"TSMSIDC requires at least

15 lakh (1.5 Million) to 20 Lakh (2 Million) doses of the vaccine to be supplied every month. The supplies have to be initiated within 7 days of release of purchase order & completed within 30 days," the document said.

Bidders can quote their offers to supply the vaccine in part also, provided monthly supply shall not be less than 1.5 million and the total supply of 10 million doses shall be completed within 6 months from the issuance of Letter of Intent (LoI), it said.

Jaishankar targets Kejriwal over 'Singapore virus'

SHURHA.IIT ROY& **MALLICA JOSHI** NEW DELHI, MAY 19

AFTER SINGAPORE conveved its "strong objection" over Delhi Chief Minister Arvind Kejriwal's warning of a Covid strain from that country, External Affairs Minister S Jaishankar assured the island nation that it was India's "solid partner" in the fight against the virus. But in an unusual departure from norm, he also targeted Kejriwal for "irresponsible comments from those who should know better" and said the "Delhi CM does not speak for India".

The Ministry of External Affairs (MEA), too, took aim at the Delhi Chief Minister, saying he had "no competence to pronounce on Covid variants or civil aviation policy" in reference to Kejriwal's call for a halt to air services from Singapore.

Responding to Jaishankar's comments. Delhi Deputy Chief Minister Manish Sisodia put up a brave front, saying that Kejriwal's statement was to express worry for the children of the country while "the Centre is only focusing on its image abroad"

Later, Singapore's Foreign Minister Vivian Balakrishnan, too, spoke out on the issue, saying "politicians should stick to facts" and that there is no "Singapore variant" while posting a piece on Indian Covid variants from "Nature", the science magazine.

Thanking Jaishankar, Balakrishnan said, "Let's focus on resolving the situation in our respective countries and helping one another. Nobody is safe until everyone is safe."



Delhi CM does not speak for India, said Jaishankar

On Tuesday, Kejriwal had said that a Covid variant found in Singapore could usher a third wave in India, and it could be especially dangerous for children. He also appealed to the Centre to immediately halt air services from Singapore.

On Tuesday Singapore's Health Ministry responded that "there is no truth whatsoever in the assertions' and that there is no "Singapore variant". "The strain that is prevalent in many of the COVID-19 cases in recent weeks is the B.1.617.2 variant, which originated in India, Phylogenetic testing has shown this B.1.617.2 variant to be associated with several clusters in Singapore," it said.

On Wednesday, Singapore's Foreign Ministry said that it "regrets the unfounded assertions" and is "disappointed that a prominent political figure had failed to ascertain the facts before making such claims". It said that the Ministry summoned Indian High Commissioner P Kumaran "to express these con-

spokesperson Arindam Bagchi said: "Singapore Government called in our High Commissioner today to convey strong objection to Delhi CM's tweet on "Singapore variant". High Commissioner clarified that

In New Delhi, MEA's official

Delhi CM had no competence to pronounce on Covid variants or civil aviation policy."

Minutes later, Jaishankar took to Twitter. "Singapore and India have been solid partners in the fight against Covid-19. Appreciate Singapore's role as a logistics hub and oxygen supplier. Their gesture of deploying military aircraft to help us speaks of our exceptional relationship," he posted.

"However, irresponsible comments from those who should know better can damage long-standing partnerships. So, let me clarify - Delhi CM does not speak for India," he posted.

Speaking to reporters, Sisodia accused the Centre of not caring about children, and the BJP of starting "low-level politics".

"Reactions from the Centre and BIP make it clear that while Keiriwal is worried about children, BJP and Centre are worried about Singapore. The Centre and BJP do not worry about children." Sisodia said.

Sisodia also accused the Centre of not having taken seriously the variant that had developed in London. "Scientists had warned about the new strain. The Government did not pay heed and because of that strain and because of the Centre's laxity, look at what has happened in the country," he said.

"Today doctors and scientists are again saying that children are at risk in the next wave but we are not ready to understand. The issue is not Singapore, it is children...You want to play politics over Singapore, we are asking with folded hands to save our children... The Centre is free to worry about their image, we will worry about our children," he

Delhi HC issues notice to Centre, **Bharat Biotech** over Covaxin trials on minors

THE DELHI High Court on Wednesday issued a notice to the Centre in a plea seeking setting aside of the permission granted to Bharat Biotech for conducting phase II and phase III clinical trial of Covaxin on children belonging to the 2-18 group.

The division bench of Chief Justice DN Patel and Justice Jyoti Singh, however, declined to issue an interim order in the case and listed the case for hearing on July 15. It also issued a notice to Bharat

In the petition filed by advocate Sanjeev Kumar, it has been argued that subjects of the clinical trial being minors cannot be supposed to be 'volunteer' for clinical

The plea further states that parents or legal guardians of children are authorized to give consent for administration of a drug or for conducting any operation on the body of the child to save their life, but the situation is different in the conduct of the clinical trials.

"The trial under impugned order shall be conducted on the otherwise healthy toddlers and children who are not at all facing any risk of life, and therefore, such an action shall clearly amount to causing homicide with knowledge of doing so which, in turn, happens to fall under the category of culpable offence," it adds.

Kumar has also contended that it cannot be ruled out that parents or legal guardians could have extended their consent out of questionable enticements.


